

# Witness Statement - Officer Colt

## WITNESS STATEMENT

I, **Peter Colt**, voluntarily, without threats or promises, make the following statements:

**Q: What is your name?**

On 03/20/2015 at approximately 2321Hrs. I was dispatched to 125 Cleveland St. basement apartment, with Car 351 Ptlm. Muldoon, and Car 353 Ptlm. Perez for a report of a disturbance, subjects fighting in the basement apartment. Car 354 Ptlm. Kanelopoulos and Sector 5 Ptlm. V. Lopez responded as well. Upon arrival a neighbor told me that one of the couples in the basement apartment was fighting. I observed blood on the walls of the common access hallway.

I entered the right hand apartment and observed a tall male subject, naked from the waist standing over a female subject laying on the floor moaning. I observed blood on the bed, the floor and other furniture. I also observed several pieces of broken crockery on the floor. I observed Ptlm. Kanelopoulos place the male subject later identified as Victor Colebut DOB 11/10/1978 in handcuffs. I observed Colebut to have several scratches and bite marks to his stomach, chest and arms. Colebut was secured in a marked Police car.

When I tried to interview the female identified as Kristine Ohler 19, became hostile toward us. Even though Ohler's face and arms were bloodied she refused rescue. She stated to me, "I don't need rescue and I don't need you. Get the fuck out of my house." I tried to explain that they had to ensure her well-being. Ohler stated "Fuck you, get the fuck out of my house you fucking assholes." She then stood up, went into the common access hallway and began to bang on a neighbors door yelling loudly; "Help me the Police won't leave me the fuck alone." The neighbors loudly and clearly stated; "Go away, stop banging on our door."

We again tried to reason with Ohler who then pushed Ptlm. Muldoon away. I then informed her that she would be arrested if she continued. Ohler then said, "Fuck you guys, fuck you all." Muldoon and I attempted to grab Ohler's arms but she leaned back, cleared her throat and spit blood and mucus at Ptlm. Muldoon. Ptlm. Perez was able to pull Ohler and instead of spitting in Ptlm. Muldoon's face she spit on his jacket and pants. We then began to handcuff Ohler who kept twisting and pulling away. Ohler then began to bang her head on her neighbors door screaming; "Help, Help the Police are smashing my head into the wall." After a brief struggle we secured Ohler in the back a marked Police car. Ohler began to smash her head against the glass.

I then spoke to Colebut who stated that he walked into the bathroom while his girlfriend Ohler was in it. She grew angry and to swing a stick at him. He was able to take the stick away from her. She then began to smash crockery, scratch and bite Colebut. Colebut pushed her away to defend herself and in the process struck her in the nose. I determined that Ohler was the primary aggressor. Colebut refused to sign the DVSA1 or fill out an SVU witness statement and would not cooperate with Police further.

Rescue responded and treated Ohler on scene.

Sgt. Yekelchik responded to the scene.

Ohler was transported to Central Station without further incident and held for the next session of 6<sup>th</sup> district court.
