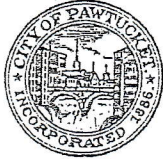
PAWTUCKET POLICE CRIME SCENE LOG


